ORDER OF CANCELLATION

This matter having come on for consideration before Jesse White, Secretary of State, through his designated representative, the Securities Director, and having been fully advised in the premises by the staff of the Illinois Securities Department, Office of the Secretary of State, (the "Department") herein finds:

1. That EKN Financial Services Inc. (the "Respondent") is now and at all times relevant hereto was registered as a dealer in the State of Illinois pursuant to Section 8 of the Illinois Securities Law [815 ILCS 5/1 et seq.] (the "Act").
2. That on or about October 12, 2012, the Respondent was expelled from membership in the Financial Industry Regulatory Authority, Inc. ("FINRA") pursuant to FINRA Rule 8313(e) in case #2008011665801 for making materially false misrepresentations to FINRA in seeking and obtaining FINRA approval for subordinated loan and loan extensions; failing to establish and maintain procedures reasonably designed to achieve compliance with Anti-Money Laundering (AML) rules and regulation and failing to both detect and report suspicious activity; conducting a securities business while in a Net Capital deficiency, preparing inaccurate Net Capital Computations, failing to file accurate notifications of Net Capital deficiencies, and failing to record accurately expenses and liabilities in its books and records; Failing to disclose judgments and liens on salespersons' respective Forms U4; Failing to file or amend Forms U4 and U5 to disclose regulatory and customer complaints; failing to supervise EKN's registered representatives and associated persons in numerous areas, including financial operations, heightened supervision, producing managers and customer fund; failing to maintain emails and other correspondence with the public or evidencing

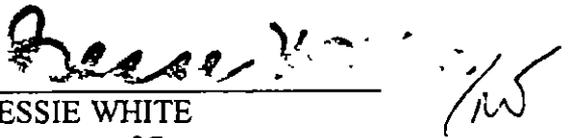

review of incoming and outgoing correspondence; and failing to respond to FINRA requests for documentation and information as to; among others, its parent company and investor.

3. That Section 8.E(2) of the Act provides, inter alia, that if the Secretary of State finds that any registrant or applicant for registration is no longer in business as a dealer or cannot be located after reasonable search, the Secretary of State may by order cancel the registration or application.
4. That the Department has determined that the Respondent has ceased to do business as a dealer in the State of Illinois.
5. That it is in the public interest to enter an order which cancels the dealer registration of the Respondent EKN Financial Services, Inc. in the State of Illinois.

NOW THEREFORE IT IS HEREBY ORDERED: That the dealer registration of the Respondent EKN Financial Services, Inc. in the State of Illinois is hereby cancelled.
