Driver's License Reinstatement Payment

The Office of the Secretary of State offers several convenient methods to pay reinstatement fees for driver's license suspensions:

- The most efficient and fastest way to pay reinstatement fees is by credit card through the Secretary of State's website at www.cyberdriveillinois.com.
Payments may be mailed into the Springfield office in the form of personal checks, money orders, or by completing the below credit card form.
Cash or credit card payments may be made in person at the Driver Services facilities listed on the back of this publication.

Reinstatement Fee Credit Card Payment Mail-in Form

Once a credit card account has been verified to ensure it is valid and in good standing, the account will immediately be charged the amount owed to the Secretary of State, plus a minimal convenience fee. Please note that this method will take a minimum of three to five business days to process once received by the office.
